


#### **The LGBT Community Center of Greater Cleveland**

He currently provides HIV and STI testing and PrEP access all across the city of Cleveland at various non-clinical spaces, such as bars, festivals, events, and the bathhouse, promoting HIV and STI education and reducing the stigma associated with HIV.



## **Cleveland Burlesque and Ohio Burlesque Festival**

Mx. Juneteenth is a free event created by and for Black queer folx to celebrate Juneteenth, a holiday for reverence, remembrance, and celebration of freedom. It is a Black and queer liberation celebration that centers radical politics, community care, and expressive joy. Mx. Juneteenth is one of many local 2SLGBTQIA+ organizations recognized as an honorary community partner of the Greater Cleveland LGBTQ+ Community Needs Assessment.

#### **Transwellness Resources and Support Network**

Transwellness Resources and Support Network offers a wide range of services and resources, including HIV and STD prevention, trans activism, community outreach, and safe sex kits. They provide trans education and training, case management, and assistance with essential legal and administrative tasks such as name changes, birth certificate updates, gender marker corrections, identification and EBT applications, marriage notary services, and support for CMHA applications. Additionally, they offer access to a food pantry, shelter and job referrals, healthcare and health insurance assistance, and a welcoming drop-in space for cyber activities or simply connecting with others in the community.

Transwellness Resources and Support Network is one of many local LGBTQ+ organizations recognized as an honorary community partner of the Greater Cleveland LGBTQ+ Community Needs Assessment.



Devinity Jones is the Founder and Executive Director of Transwellness Resources and Support Network, where she advocates for transgender individuals by providing access to essential services like healthcare, housing, and mental health resources. As a Black transgender woman, Jones has faced significant adversity, including homelessness and sexual violence, but has emerged as a strong leader in the community. Her personal experiences have fueled her dedication to helping others, particularly through her work supporting transgender individuals who face systemic barriers.

Jones is also a vocal advocate for addressing the violence and discrimination that disproportionately affect Black transgender women. She continues to honor the memory of trans women like Tierramarie Lewis, who was tragically murdered in 2021, by pushing for greater protections and inclusivity. Through her work and advocacy, Jones is committed to creating a safer and more supportive environment for the transgender community in Cleveland and beyond.

# Introduction, Purpose, and Goals of this Community Needs Assessment


Community needs assessments are tools public health professionals use to collect, synthesize, and disseminate valuable information to support and validate decision-making and commitments to implementing community health interventions, resources, and investments. Capturing insight about the current health status and potential accomplishments as well as deficiencies in community services and community resources inform key stakeholders—both within and outside the healthcare sector—who are committed to delivering culturally competent services to the 2SLGBTQIA+ community. This contributes to the overall improved health status of the target population.

Community needs assessments are an essential tool for identifying the strengths, opportunities, and resources available in a community to meet the unmet needs of the people living there. Community needs assessments also provide valuable insight and information for identifying and developing innovative solutions to service gaps and building a supportive community to live in. As 2SLGBTQIA+ individuals and as a community, we have abundant strength, resilience, and resourcefulness. At the same time, our community continues to be disproportionately affected by a range of physical, mental, and behavioral health, economic, social, legal, and political issues. Many organizations may overlook our needs because they don't understand what our needs are.

#### Needs Assessment Goals

- Increase awareness about public health as it relates to the 2SLGBTQIA+ community in Greater Cleveland.
- Lean into the local 2SLGBTQIA+ population demographically as the 2SLGBTQIA+ community is currently unassessed by the US Census, leaving us to rely on estimates.
- Describe the status of the local 2SLGBTQIA+ community holistically; not just focusing on weaknesses and unmet needs but also identifying strengths and achievements.
- Develop a set of community recommendations based on participant input that inform future investments and decision-making for the local 2SLGBTQIA+ community.
- Strengthen partnerships and collaborations between organizations within the local public health system.





Our research methodology showcases the carefully planned and gathered data for this report. By combining proven research techniques with strategic analysis, we have ensured the insights reflect real community challenges and provide actionable, impactful solutions.

#### **Research Methodology**

#### **Planning**

The Greater Cleveland LGBTQ+ Community Needs Assessment was conducted from January 2023 to December 2024 using a community-based participatory research (CBPR) approach. This approach prioritized collaboration with 2SLGBTQIA+ community members and stakeholders across diverse sectors. The project was guided by nine committees: a Steering Committee, a Diversity, Equity, Inclusion, and Belonging (DEIB) Committee, and seven sub-committees, collectively representing a holistic approach to community health. These sub-committees included Health and Wellness, Religion and Spirituality, Education and Literacy, Housing, Food, and Basic Needs, Business, Employment, and Commerce, Safety and Law Enforcement, and Recreation and Leisure.

These leadership teams were composed of over 180 individuals from more than 120 organizations, including health services, educational institutions, and 2SLGBTQIA+ advocacy groups. The planning process, facilitated by a Program Director and four graduate students from Kent State University's College of Public Health, involved developing clear objectives, establishing recruitment strategies, and identifying key community issues to assess.

Each sub-committee, consisting of 2SLGBTQIA+ community members, subject experts, professionals, and stakeholders, participated in a series of ten 90-minute virtual meetings. These meetings guided the teams in defining the Greater Cleveland 2SLGBTQIA+ Community, conducting SWOT analyses, identifying concerns, determining researchable questions, and selecting appropriate data collection mechanisms. The sub-committee's work was reviewed by the Steering and DEIB committees, with feedback incorporated through monthly virtual meetings.

#### Community Survey

The primary means of data collection was a comprehensive digital survey co-developed by the project committees to cover critical health domains and community needs. Recruitment occurred through social media, in-person engagement at 2SLGBTQIA+ community events and significant venues, and flyer distribution in collaboration with community partners across Cuyahoga, Geauga, Lake, and Lorain counties.



The core project team attended and posted flyers at over 120 events and venues. Participants included individuals aged 12 or older, with parental consent for those under 18, identifying as 2SLGBTQIA+ or 2SLGBTQIA+ allies living in the target counties or relying on Greater Cleveland for resources. Survey participants were incentivized with a raffle for one of 35 gift cards from local 2SLGBTQIA+-owned or affirming businesses valued at \$75 each.

Survey metrics reveal that the Greater Cleveland LGBTQ+ Community Needs Assessment gathered a total of 2,006 unique survey responses. Of these respondents, 1,653 (82.5%) identified as 2SLGBTQIA+, with 1,594 adults and 59 youth. Additionally, 353 (17.5%) respondents identified as 2SLGBTQIA+ allies, including 350 adults and 3 youth. The BIPOC 2SLGBTQIA+ response rate response rate was 22.4% (371 responses). The overall completion rate was 75%. There were six surveys completed in Spanish. In total the community survey collected 363,041 unique data points.



#### Intersectionality Listening Sessions

Intersectionality listening sessions (focus groups) were held with historically underrepresented subcommunities, identities, subgroups, and shared experience. These sessions employed a qualitative approach to create a safe space for participants to share their specific challenges and needs. A total of 178 participants engaged in 26 ninety-minute sessions held at the LGBT Community Center of Greater Cleveland, El Centro De Servicios Sociales, Colors+, Geauga Public Library, Lake County Health Department, and B. Riley Sober House. Participants were compensated with a \$50 prepaid Visa gift card for sharing their time and experiences with the project.

Facilitators led guided discussions to identify and prioritize unmet needs, existing resources, barriers to access, and potential solutions and calls to action. The insights from these sessions were crucial in ensuring underrepresented voices were central to the needs assessment process.

#### Stakeholder Interviews

Semi-structured interviews were conducted with 23 key stakeholders from community organizations, healthcare providers, and government. These interviews aimed to gather in-depth insights into the systemic challenges faced by the 2SLGBTQIA+ community and identify potential areas for intervention. Stakeholders were selected for their expertise and involvement in 2SLGBTQIA+ issues, ensuring diverse perspectives. Interviews were anonymous, recorded, transcribed, and thematically analyzed to highlight common concerns and strategic recommendations for improving community health outcomes.



#### Strengths


- Robust Participation: The assessment recorded 2,006 valid and unique survey responses, providing a rich dataset with a high completion rate that reflects the diverse experiences within the 2SLGBTQIA+ community of Greater Cleveland.
- Mixed-Methods Approach: Utilizing both quantitative and qualitative data allows for a comprehensive understanding of the community's needs and priorities.
- Community-Partnered Approach: The project piloted a recruitment method that equitably compensated eight community organizations and individuals with access to hard-to-reach 2SLGBTQIA+ sub-community members, working hand-in-hand with the core project team to recruit potential participants for the survey and listening sessions, increasing the diversity of the final sample.

#### Limitations

Sampling Bias: The non-probability convenience sampling approach led to potential underrepresentation of certain intersections within the 2SLGBTQIA+ community, such as intersex individuals, 2SLGBTQIA+ youth of diverse racial and ethnic backgrounds, 2SLGBTQIA+ individuals experiencing homelessness or housing insecurity, 2SLGBTQIA+ seniors (over 65), and 2SLGBTQIA+ individuals from Middle Eastern, North African, Asian American, Pacific Islander, and American Indian and Native Alaskan backgrounds.

- Access Barriers: Further local research with these identities in particular should be conducted in the future to better understand and meet the needs of these 2SLGBTQIA+ community members.
- Age Restriction: Data collection did not include 2SLGBTQIA+ community members under the age of 12, which may overlook critical insights from younger demographics.
- Self-Reported Data: The assessment relied on self-reported data, which can be subject to biases, including over- or under-reporting behaviors, experiences, or needs. Respondents may have provided socially desirable answers rather than accurate reflections of their circumstances.
- Response Bias: Certain groups may have been more likely to participate in the survey or focus groups, leading to a response bias. Individuals who are more engaged or have stronger opinions may have skewed the results toward those perspectives.
- Limited Generalizability: Due to the non-random, convenience sampling method, the findings may not be fully generalizable to the entire
   2SLGBTQIA+ population or to other regions outside Greater Cleveland. The specific needs identified may be unique to the respondents.





#### **Community Recommendations**

The following list of prioritized community recommendations was taken from our survey question, "What do you need to address your biggest fear, worry, or concern for yourself as a member of the LGBTQ+ community?"

- Foster a culture of inclusiveness, open-mindedness, empathy, acceptance, and respect within and outside the LGBTQ+ community.
- Address uncertainty and feelings of helplessness by promoting actionable solutions and community engagement.
  - Increase accessible community education, including health, civic education, cultural competency, allyship, law enforcement training, workplace training, intersectionality, mediation techniques, and first aid and emergency preparedness.
- Build safe LGBTQ+-friendly resources, including medical services, childcare and family planning, coming out support, political resources, relationship/dating resources, addition recovery and prevention resources, affirming medical schools/institutions, affirming lawyers and legal services, LGBTQ+-owned business, Cleveland providers, and self-defense tools.

- Enact and enforce laws against discrimination, including those related to gender affirming care, workplace rights, reproductive rights, family rights, marriage rights, gender markers on government documents, housing policy, and taxation on non-spousal health benefits.
- Invest in accessible support programs and groups for LGBTQ+ community members, allies, and general community members such as youth outreach, mentoring, networking, social groups and services, safe online spaces, and groups for autistic LGBTQ+ individuals.
- Ensure government and local leaders actively support the LGBTQ+ community.
- Promote active allyship within and outside the LGBTQ+ community, including trans allyship, BIPOC allyship, and lesbian allyship, with support from institutions, businesses, and silent funders.
- Build more LGBTQ+-friendly safe spaces, community areas, and neighborhoods, including CO-OPs, city planning, third spaces outside of bars and clubs, inclusivity and pride indicators, art collaborations to beautify community spaces, gender-neutral bathrooms, and safety improvements to existing LGBTQ+ spaces.
- Support political and legal advocacy and activism around LGBTQ+ issues, including actions from healthcare institutions, youth empowerment, and union organizing.

This includes individuals whose identity may not be expressly included in the acronym 2SLGBTQIA+, or may not publicly identify or "out" themselves but still feel they belong to the community.






#### What sex were you assigned at birth?






### How much do you make in a year from all sources before taxes?


## In what branch or branches did you or do you serve on active duty? (select all that apply)


## In your day-to-day life, how often do any of the following things happen to you related to your experience of <u>racial discrimination</u>?


## In your day-to-day life, how often do any of the following things happen to you related to your experience of <u>LGBTQ+ discrimination</u>?



For the purpose of this project, we take a holistic approach to health and wellness, encompassing respondents' needs and concerns across all dimensions of well-being, including physical, mental, behavioral, emotional, social, sexual, medical-legal, occupational, and spiritual health, throughout their lifespan. We understand the various factors that impact health and wellness, such as access to quality care and coverage, and acknowledge the importance of health literacy in health issues that disproportionately affect the 2SLGBTQIA+ community.

To achieve health equity, we recognize the need to assess institutional and community barriers that limit healthcare access, such as stigma and discrimination. We advocate for trauma-informed, gender-affirming, and culturally competent care to ensure that 2SLGBTQIA+ individuals have access to competent healthcare providers. We acknowledge the challenges faced by rural LGBTQ+ communities in accessing culturally competent healthcare services, and the need for alternative and community spaces for providing healthcare and prevention services.

We also recognize the importance of continuity of care across institutions serving the 2SLGBTQIA+ community, as well as the needs of caregivers, including healthcare proxies and power of attorney. We acknowledge and welcome the involvement of 2SLGBTQIA++-identifying healthcare providers in providing competent and inclusive care.

Additionally, we prioritize wellness by providing coping skills specific to the 2SLGBTQIA+ community, and promoting self-advocacy, education, and training.

We acknowledge the value of collecting sexual orientation and gender identity data and implementing appropriate data standards.
















#### What are the reason(s) you are currently uninsured? (select all that apply)












## Do you use telemedicine to access your gender-affirming hormone treatment licensed medical provider?





For the purpose of this project, when referring to religion and spirituality, we acknowledge respondents' religious and spiritual beliefs and practices as integral to their identities. We aim to assess the inclusion of 2SLGBTQIA+ individuals in religious and spiritual communities and the impact of religion and spirituality on the physical, mental, social, spiritual, and behavioral health and well-being of 2SLGBTQIA+ individuals.

We recognize that definitions of religion and spirituality are diverse and individualistic and that seeking guidance beyond oneself and connecting with a higher power can take many forms.


This domain emphasizes identifying concerns related to the inclusion of 2SLGBTQIA+ individuals in religious and spiritual communities, exploring the impact of religion and spirituality on health, promoting greater understanding and acceptance, and assessing the historic religious trauma of 2SLGBTQIA+ individuals within diverse religious and spiritual traditions.






### Have you ever been involved in conversion therapy?






# Was your participation in conversion therapy in response to a religious or spiritual belief or concern?




Have religious teachings about gender identity, gender expression, or sexual orientation ever made you feel a diminished sense of self-worth?















We aim to assess learning environments to ensure learners and educators feel represented, have a sense of belonging, and are supported. We also acknowledge the importance of enhancing health literacy, financial literacy, and media literacy among LGBTQ+ individuals.



In our efforts to ensure equal access to education and literacy resources, we aim to assess the barriers around safety and policy initiatives related to LGBTQ+ topics and issues.










## How often have you been worried about your physical safety in your educational setting(s)?








#### Do you feel you received enough LGBTQ+ sex education in school?


















## What factors are most important to you when choosing your home or apartment? (select all that apply)




## What are the barriers, if any, that keep you from living in another part of your community? (select all that apply)




## How many people live in the place where you stay? (including yourself) 326 Responses




#### In general, how healthy do you feel your overall diet is?






How many days per week do you eat meals prepared in your home?


Food insecurity is when you are unable to access or afford enough food consistently. Have you ever in your life experienced food insecurity? (select all that apply)



#### At what age range(s) have you experienced food insecurity? (select all that apply)



#### How often do you experience food insecurity?



#### How often did you experience food insecurity in the past?






#### Where do you usually get your groceries? (select all that apply)




## Do you have a computer or laptop with internet access at the place you live or stay that you can use?



#### Where do you usually access/use the internet? (select all that apply)




## Do you have a smartphone with internet access? (a phone that also has computer capabilities and accesses the internet)



#### Do you have access to a reliable form of transportation?




Is it hard for you to use or get any of the following transportation related needs? (select all that apply)




Where do you go to find LGBTQ+ community information, support, or resources? (select all that apply)




Do you think it would be helpful to have one centralized place to house all LGBTQ+ affirming community support and resource information, so you don't have to go to different places to find it?



## What format would you prefer this type of information to be available? (select all that apply)







We also aim to consider the needs of newcomers, particularly those in the refugee community, to ensure that they feel supported and included in the business and employment sector in Greater Cleveland.












Tell us about how often you experience any of the following in the hiring process or during interviews that you have had in the past.




# Have you ever felt discriminated against based on your sexual orientation or gender identity at work?


# What kind of workplace discrimination have you experienced based on your sexual orientation or gender identity? (select all that apply)




Does your current employer have rules/regulations/policies in place for those who have experienced workplace discrimination based on their sexual orientation or gender identity?





# How physically safe do you feel in the following situations and settings? 316 Responses




Have you ever experienced LGBTQ+ discrimination in the following places or situations? (select all that apply)


Are there certain parts of Cuyahoga, Lake, Lorain, or Geauga counties that you worry about your safety or acceptance because of your LGBTQ+ identity?


Have you been arrested, detained by, or had a negative interaction(s) with a law enforcement officer or the justice system in the past five (5) years?






# How often are the following statements true pertaining to your arrest, detainment or interactions with the justice system?



Did you use any kind of personal legal help or services in the past five (5) years? 297 Responses




#### Where did/do you usually get these legal services? (select all that apply)






#### Do any of these make it hard for you to get legal support? (select all that apply)






In the past five years, have you ever been bullied because of your LGBTQ+ identity? 304 Responses




In the past five years, have you ever been electronically bullied (count being bullied through texting, Instagram, Facebook, or other social media)?





# Select the types of activities you enjoy watching or participating in. (select all that apply)




Do any of the following barriers prevent you from participating in recreating and leisure activities that you enjoy as much as you would like to? (select all that apply)




In general, do you prefer LGBTQ+ specific programming and events over general community programming and events?

Intersectionality listening sessions were conducted with individuals of color within the 2SLGBTQIA+ community to document their unique perspectives and challenges. These sessions provided a vital platform for participants to voice their experiences with intersectional discrimination, as well as the barriers they face in accessing resources and support.



# Latiné, Latinx, Latino, Hispanic and Spanish LGBTQ+ Community

Latiné, Latinx, Latino, Hispanic, Afro-Latino, and/or Spanish LGBTQ+ community members, over the age of 18, who reside in Cuyahoga, Lake, Lorain, or Geauga County or the surrounding area.

#### Community Priorities and Calls to Action Identified:

- Establish community-centric free support groups to address the stigma, access, and cost of mental health resources.
- Implement training programs in LGBTQ+ venues to reduce discrimination based on language barriers and accents, fostering a more inclusive environment.
- Increase awareness and intervention programs to address violence and bullying, promoting safer spaces within the community.
- Foster collaborative efforts between intersectional community groups and organizations to provide comprehensive support.
- Enforce anti-discrimination policies in workplaces and provide support for those facing workplace racism.
- Enhance safety measures in digital spaces and public transit, including more safety/security staff and better enforcement of legal protections.
- Provide legal services through existing support organizations to assist with navigating legal documentation issues.
- Allocate budget and prioritize the translation of resources and materials into Spanish, ensuring accessibility for non-English speakers in LGBTQ+ spaces and events.

"The inclusion of Latino queer individuals in Cleveland is still a relatively new practice. studies like this one not only address this by creating space but also provided accessible language and resources for a community that has long needed visibility and information. While the work has begun, I am eager to see its continued development and growth in the future."

# Black and African American LGBTQ+ Community

Black, African American, and/or Afro-latino LGBTQ+ community members, over the age of 18, and reside in Cuyahoga, Lake, Lorain, or Geauga County or the surrounding area.

#### **Community Priorities and Calls to Action Identified:**

- Expand services for affordable housing, particularly on the east side of Cleveland, and establish more LGBTQ+-friendly housing options.
- Address food insecurity by creating more accessible and healthy food options and improving transportation to these resources.
- Develop and support intersectional spaces for Black LGBTQ+ individuals, fostering a sense of community and belonging.
- Implement policies and training programs to reduce discrimination in nightlife and other social spaces, ensuring inclusivity and safety.
- Enhance public transportation safety measures and provide more options for accessing healthy food.
- Improve access to healthcare by addressing systemic barriers, increasing supportive resources, and ensuring inclusive and affirming care for Black LGBTQ+ individuals.
- Create microgrant programs and networking opportunities for Black LGBTQ+ artists and independent workers to support their creative and professional endeavors.
- Strengthen community-based services to address intersectionality and historical trauma, ensuring they are robust and inclusive.

The ME/NA LGBTQ+ community remains underrepresented in our sample, which may be attributed to several factors, including geographical isolation, historical marginalization, and the mistrust of research initiatives due to past exploitation and cultural insensitivity. Despite having collected insights on the following community priorities and calls to action, our team would like to highlight the need for more inclusive and targeted efforts to ensure their voices are adequately heard and represented in future research and community assessments.

#### Community Priorities and Calls to Action Identified:

Promote opportunities for ME/NA people in management and other power positions within the LGBTQ+

· community.

Utilize government grant programs to repurpose empty and unused real estate, such as Airbnbs,

- for affordable housing for immigrants and homeless LGBTQ+ youth.
- Foster volunteering and financial assistance programs from large organizations to support emergency food, shelter, and voucher services. Implement food recycling programs.
- Develop educational resources and outreach programs to enhance understanding of religious and cultural beliefs. Include required workplace training on these topics.
- Create and distribute educational resources for LGBTQ+ education in the ME/NA community,
- emphasizing safety, acceptability, and receptiveness.
   Promote Queer ME/NA safe spaces through TV ads and other confidential channels.
- Implement educational resources and required training in workplaces to combat ME/NA
- discrimination, focusing on microaggressions and colorism. Foster more sensitivity and language education.
  - Provide educational resources and training for the LGBTQ+ community about ME/NA cultures and
- intersectionality. Include outreach to physicians in training, clinical programs, and workplaces. Expand case management services by creating more paid positions for community health workers
- both within the health system and the community.
   Develop third-party representation, interpreters, financial assistance, and community outreach
- to support ME/NA individuals needing resources for citizenship, documentation, and safety. Encourage support from the LGBTQ+ community to foster buy-in from the ME/NA community.

The AA/PI LGBTQ+ community remains underrepresented in our sample, which may be attributed to several factors, including geographical isolation, historical marginalization, and the mistrust of research initiatives due to past exploitation and cultural insensitivity. Despite having collected insights on the following community priorities and calls to action, our team would like to highlight the need for more inclusive and targeted efforts to ensure their voices are adequately heard and represented in future research and community assessments.

#### Community Priorities and Calls to Action Identified:

- Support the expansion and resourcing of existing AA/PI queer organizations like OPAWL to increase accessibility and outreach within the community.
- Advocate for education and cultural competency training within AA/PI-serving organizations to ensure LGBT inclusivity and trauma-informed care.
- Facilitate the establishment of new inter-organizational groups tailored to the diverse needs of AA/PI LGBTQ+ people, fostering community and support across generational and cultural differences.
- Promote media portrayal and visibility of AA/PI LGBTQ+ individuals, advocating for their inclusion in community events, social justice initiatives, and government policies without tokenization.
- Organize listening sessions and cultural exchanges to bridge inter-community cultural differences and foster understanding among adopted and emigrated AA/ PI individuals.

# American Indian and Alaska Native LGBTQ+ Community

American Indian and/or Alaska Native LGBTQ+ community members over the age of 18 who reside in Cuyahoga, Lake, Lorain, or Geauga County.

While this community spotlight aims to shed light on the experiences and needs of American Indian and Alaska Native (Al/AN) LGBTQ+ individuals, it is important to acknowledge the limitations of our study. The Al/AN LGBTQ+ community remains underrepresented in our sample, which may be attributed to several factors, including geographical isolation, historical marginalization, and the mistrust of research initiatives due to past exploitation and cultural insensitivity. Despite many attempts by our team to host intersectionality listening sessions for this part of our community, we were unable to engage this important part of our community in collecting qualitative lived experiences.

Due to the lack of identifying community priorities and calls to action directly from AI/AN LGBTQ+ community members and to address these limitations and enhance future engagement and representation of the AI/AN LGBTQ+ community in future initiatives, our team proposes the following actions:

- Build trust with the AI/AN LGBTO+ community through cultural competency
- Increase outreach and accessibility to the AI/AN community
- Strengthen community partnerships with historically trusted AI/AN serving organizations
- Promote inclusive policy and advocacy for the AI/AN LGBTO+ community
- Provide funding and resources

By implementing these actions, we can work towards a more inclusive and representative understanding of the AI/AN LGBTQ+ community, ensuring that their voices are heard, respected, and valued in all aspects of research and community engagement.

"With being Indigenous as well as a woman, I get talked down too a lot! People have no idea what a 2 spirit person is. I have to be firm and hold my ground. I try to pave the way for the 2 spirit people's after me."
